A Review of Children's Rights in Northern Ireland 2007/08





am pleased to present the findings of this review of children's rights in Northern Ireland in 2007/08. I hope this report will help inform thinking and decision-making over coming months and years to improve the lives of all Northern Ireland's children and young people.

It is my job to promote and safeguard the rights and best interests of children and young people, to help them challenge and change the world they live in. I do this in a number of different ways, including making sure that children and young people's participation is at the core of my work. This fulfils the role outlined when the Northern Ireland Assembly created the Commissioner's post.

Under the legislation which created my Office, I also have a specific duty to keep under review the adequacy and effectiveness of law and practice relating to, and services provided for, children and young people and to advise government on any issues concerning the rights and best interests of children and young people. It was with these duties in mind that I undertook this review of children's rights in Northern Ireland.

The rights framework adopted within this review is in line with my founding legislation, under which I must pay due regard to the United Nations Convention on the Rights of the Child (UNCRC). Commentary made by the Committee on the Rights of the Child, in particular its most recent Concluding Observations on the UK (issued in October 2008), is therefore integrated throughout this review.

The review highlights many significant developments that have occurred over recent years. These include the restoration of devolution to Northern Ireland, the ongoing implementation of the Review of Public Administration and the introduction of a Ten Year Strategy for Children



and Young People. It also highlights specific areas of progress in relation to the more effective realisation of children's rights within Northern Ireland, across areas as diverse as education, juvenile justice and health.

While I welcome the progress noted within these fields, this review also highlights a significant number of areas where children's rights continue to be breached within Northern Ireland. This review pays particular attention to the experiences of children and young people who face multiple forms of disadvantage and discrimination.

The continued failure of the government to make real all the promises contained within the UNCRC, for all our children and young people, is a matter of ongoing concern. I therefore urge Ministers and government departments to consider, and act where needed, on the findings of this review and to implement immediate and determined action to prioritise the rights and best interests of children and young people across all aspects of legislation, policy and practice.

I also hope the findings of this review will prove useful for all those who are interested in, and dedicated to, improving children and young people's lives through more effective realisation of their rights.

Together we can continue to work towards a better future for all our children and young people.
